Superintendent Brent Jorth, School Business Official Jackie Wells, PK-6 Principal Steve Harman, 7-12 Principal Jason Engleman, Kristi Wright, Anna Warntjes and Emerson Kelderman were also in attendance.

President Koob called the meeting to order at 5:02 P.M.

Davis moved to approve the agenda with an additional list of bills and Postma seconded, carried 3-0.

Postma moved to approve minutes of past meetings as presented. Davis seconded, carried 3-0.

Director Jans arrived at 5:04 P.M.

Koob requested nominations for Vice-President of the Central Lyon Board of Directors. Koob nominated Jans, Postma seconded. Nominations ceased and the oath of office was administered to President Koob and Vice-President Jans.

Hartter will serve on the Lyon County Assessors' Board. Davis will serve as the board representative for the Central Lyon Foundation. Jans and Hartter will serve on the School Improvement Advisory Committee (SIAC). Postma seconded, carried 5-0.
